Executive Summary

Ka Mana O Na Helu (KMNH) is the Collaborative Applicant and Homeless Management Information System (HMIS) Lead Agency for Bridging The Gap (BTG) Continuum of Care and is responsible for assisting with the implementation of the local Point-in-Time Count (PIT) and reporting the findings to BTG and the U.S. Department of Housing and Urban Development (HUD). KMNH has prepared this report to convey 2025 sheltered PIT results, and to compare this data to prior years. The official night of the 2025 Sheltered PIT was Wednesday, January 22, 2025.

In June 2024, the BTG Board of Directors voted and approved to move the unsheltered PIT to every other year as required by HUD regulations. HUD requires BTG to conduct a full count (both sheltered and unsheltered PIT) every other year. Because BTG conducted an unsheltered PIT in 2024, BTG was not required to conduct an unsheltered PIT this year. HUD still expects all CoC's to submit a sheltered PIT annually, which BTG has accomplished.

This report presents a summary of sheltered homelessness, including demographic information and county profiles of homelessness by sub-population for the rural counties of Hawai`i, Kaua`i, and Maui. The goal of this report is to inform the community at large, elected officials, government agencies, and other stakeholders of the immediate sheltered homeless situation on the neighbor islands. This report provides comprehensive emergency shelter and transitional housing data to promote informed decision-making for future funding activities, local strategic planning efforts, capacity building, and program development within BTG. Findings from this year's sheltered PIT should assist the federal, state, and county government in better understanding the extent and nature of sheltered homelessness within BTG.

Results from the 2025 sheltered PIT revealed a two percent increase in sheltered homelessness from 619 total people in 2024 to 632 people in 2025. This 13-person rise can be attributed to increases in the counties of Hawai'i and Kaua'i, with Maui realizing a net decrease. Hawai'i and Kaua'i counties sustained 14 and 41 percent increases respectively, driven largely by increases in homelessness among individuals, while Maui declined 10 percent overall. Maui's reduction of 37 people compared to 2024 was the result of a 17-person decrease in individual homelessness, accompanied by a 20-person decline in homelessness among family individuals.

The count of sheltered homeless persons staying in emergency or transitional facilities rose two percent from 619 to 632 people. This uptick in shelter utilization can be attributed to 26 and 24-person increases within Hawai'i and Kaua'i counties, and a reduction of 37 total people on Maui. Census data for Hawai'i, Kaua'i, and Maui on the PIT night showed occupancy of 217, 83, and 332 sheltered persons respectively.

An assessment of the type of individuals experiencing sheltered homelessness in 2025 found that of the 632 total persons enumerated, 329 were individuals, representing 52 percent of the total one-day estimate. Individuals are defined throughout this report as people in households (single or multiple adults) without children under the age of 18. A total of 303 family individuals within 82 families were sheltered this year. The 82 sheltered families identified in 2025 represents a nine percent decline relative to 2024. A total of 175 children were counted within these 82

families, up 10 children or six percent compared to 2024. In 2025, 82 sheltered families were counted (75 in emergency shelters and seven in transitional housing) encompassing 303 total people, including 175 children and 128 adults. Sheltered family homelessness declined nine percent to 82 families in 2025, down eight families compared to 2024. The largest decrease in sheltered family homelessness was on Hawai'i Island, which decreased by 8 families relative to 2024.

A review of BTG subpopulation data indicates that the total number of self-reported homeless veterans increased 87 percent to 28 sheltered veterans compared to the 2024 total of 15. Subpopulation data from 2025 shows a 43-person increase in the level of chronic homelessness among individuals compared to 2024 data, with 131 sheltered homeless individuals demonstrating chronicity. This represents a 49 percent increase compared to 2024 and indicates that 41 percent of the 319 homeless individuals residing in emergency shelters this year were chronically homeless based on HUD's definition. The chronic homelessness data presented in this report is based on self-reported responses to disability and length of homelessness questions. The 37 individuals residing in transitional housing are excluded from this calculation since people residing in these types of facilities cannot be chronically homeless. The number of chronically homeless families increased by two compared to the four counted in 2024.

This report tabulates data on sheltered unaccompanied and parenting youth households (see Appendix 1, Tables 5 and 6). Unaccompanied youth are defined by HUD as people in households without children who are not part of a family with children or accompanied by their parent or guardian during their homelessness, and who are all 24 years of age or younger. A parenting youth household is defined by HUD as a household that contains people aged 24 years or younger with one or more dependent children.

BTG reported nine total sheltered unaccompanied youth households in 2025, with all households residing in emergency shelters. The 2025 unaccompanied youth household count decreased by two households compared to the 11 households reported in 2024. In 2024, five of the 11 households were in emergency shelters, while six were in transitional facilities. In 2025, BTG reported a total of nine sheltered parenting youth households comprising 28 people, including 13 children. The number of parenting youth households reported this year increased by two compared to 2024.

Definition of Key Terms

Key terms used in this report are used for PIT reporting purposes. Definitions of these terms may differ in some ways from the definitions found in the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act and in HUD regulations.

Chronically Homeless (CH) Individual

refers to an individual with a disability who has been continuously homeless for one year or more or has experienced at least four episodes of homelessness in the last three years where the combined length of time homeless in those occasions is at least 12 months.

Chronically Homeless (CH) People in

Families refers to people in families in which the head of household or other adult member has a disability and has either been continuously homeless for one year or more or has experienced at least four episodes of homelessness in the last three years where the combined length of time homeless in those occasions is at least 12 months.

Continuum of Care (CoC) is the local planning body responsible for coordinating the full range of homelessness services in a geographic area.

Emergency Shelter (ES) is a facility with the primary purpose of providing temporary, short-term shelter for homeless people.

Family Individuals are homeless as part of a household that has at least one adult (age 18 and older) and one child (under age 18).

Homeless describes a person who lacks a fixed, regular, and adequate night-time residence.

Homeless Management Information System (HMIS) is the information system designated by the CoC to comply with the data collection requirements prescribed by HUD.

Housing Inventory Count (HIC) is produced by each CoC and provides an annual inventory of beds that assist people in the CoC who are experiencing homelessness or leaving homelessness.

Individual refers to a person who is not part of a family with children during an episode of homelessness. Individuals may be homeless as single adults, unaccompanied youth, or in multiple-adult or multiple-child households.

Other Permanent Housing is housing with or without services that is specifically for formerly homeless people but that does not require people to have a disability.

Parenting Youth are people under age 25 who are the parents or legal guardians of one or more children (under age 18) who are present with or sleeping in the same place as that youth parent, where there is no person over age 24 in the household.

Parenting Youth Household is a household with at least one parenting youth and the child or children for whom the parenting youth is the parent or legal guardian.

Point-in-Time Counts (PIT) are

unduplicated one-night estimates of sheltered and unsheltered homeless populations. The one-night counts are conducted by CoCs nationwide and occur during the last 10 days in January of each year. **Permanent Supportive Housing (PSH)** is a housing model designed to provide housing assistance and supportive services on a longterm basis to formerly homeless people. HUD's Continuum of Care program, authorized by the McKinney-Vento Act, funds PSH and requires that the client have a disability for eligibility.

Rapid Re-housing (RRH) is a housing model designed to provide temporary housing assistance to people experiencing homelessness, moving them quickly out of homelessness and into permanent housing.

Sheltered Homelessness refers to people who are staying in emergency shelters or transitional housing programs.

Transitional Housing (TH) Programs

provide people experiencing homelessness a place to stay combined with supportive services for a longer duration of time than emergency shelters.

Unaccompanied Homeless Youth (under 18)

are people in households with only children who are not part of a family with children or accompanied by their parent or guardian during their episode of homelessness, and who are under the age of 18. Unaccompanied Homeless Youth (18-24) are people in households without children who are not part of a family with children or accompanied by their parent or guardian during their episode of homelessness, and who are between the ages of 18 and 24.

Unsheltered Homelessness refers to people whose primary nighttime location is a public or private place not designated for, or ordinarily used as, regular sleeping accommodation for people (for example, the streets, vehicles, beaches, or parks).

Veteran refers to any person who served on active duty in the armed forces of the United States. This includes Reserves and National Guard members who were called up to active duty.

Overview

The 2025 Sheltered PIT represents the best available data to estimate one-day sheltered homelessness within the rural counties of Hawai'i, Maui, and Kaua'i on the night of January 22, 2025. The estimate adheres to the federal definition of homelessness which includes individuals and families residing in emergency shelters and transitional housing facilities. The count is neither a measure of stability among people residing in shelters nor a measure of the conditions of these facilities in general. HUD requires BTG to produce an unduplicated estimate of sheltered homelessness on one night during the last 10 days of January. The count is a one-day snapshot of homelessness.

The main objective during this year's count was to obtain a reliable estimate of sheltered homelessness among individuals and families. The Sheltered PIT helps to assess current levels of homelessness by household type, provide estimates for levels of veteran, chronic, unaccompanied youth, and parenting youth homelessness, and measure the prevalence of other underlying factors contributing to homelessness such as mental health and substance use disabilities. PIT reporting is an integral part of local and national planning and serves to support policy and resource allocation decisions.

BTG's Homeless Management Information System (HMIS) was utilized to extract most of the sheltered data needed for this report. HMIS data was used to count 567 of the 632 total sheltered (90 percent). The HMIS is a centralized relational database used to record services rendered to homeless individuals by service providers within BTG. Service providers receiving federal, state, or county funding participate in the HMIS as required. Some privately funded agencies voluntarily use HMIS due to its reporting capabilities.

To ensure that sheltered HMIS client and enrollment data was accurate, administrators contacted emergency shelter and transitional housing providers leading up to the count and confirmed that all clients sleeping in these facilities on the night of the count had active HMIS records. Six shelters not participating in the HMIS were contacted individually and asked to complete a manual survey for each project. Of the 632 total sheltered, 65 were counted in this way.

Sheltered data was analyzed and then used to enhance Tableau dashboards that compare trends in PIT data since 2015. These dashboards are intended to accompany the tables presented in this report and can be found on the <u>BTG Website</u> under the Reports menu.

BTG Sheltered Summary

Table 1 summarizes sheltered homelessness for BTG over the last eight years. Individual and family homelessness has been broken out to highlight year-to-year differences between these population groups. Dashboards identifying trends in homelessness for BTG, and each of the rural counties can be viewed from the link presented in the Overview section.

Year-over-year, 2025 Sheltered PIT data shows an increase of 29 individuals, and a decrease of 16 family individuals, for a net increase of 13 total people. Sheltered homelessness grew by two percent compared to 2024.

Length of Stay (LOS) Statistics for Sheltered HMIS Projects

Table 4 displays descriptive LOS statistics for the sheltered HMIS projects included in 2025. This table does not include LOS data for the six projects not participating in the HMIS. Within the emergency and transitional project types, projects are sorted by name. LOS for each client is measured from project entry through the PIT date. Data by project was then analyzed to produce the statistics below. Homeless service providers are encouraged to review LOS data in relation to overall HMIS data quality, since projects with many clients and high average LOS heavily influence BTG's system performance and tend to have less frequent bed and unit turnover.

Table 5 summarizes the total sheltered for Hawai'i Island over the last eight years. Individual and family homelessness is broken out to detail differences from year to year between these key population groups. Charts identifying trends in homelessness for Hawai'i Island can be viewed from the link presented in the Overview section.

PIT data for Hawai'i Island showed an increase in sheltered homelessness of 26 total people, growing 14 percent year-over-year. There were 22 total homeless families, eight fewer than in 2024. There were 130 total homeless individuals, 30 more than in 2024.

Maui Sheltered Summary

Table 9 summarizes the total sheltered for Maui over the last eight years. Individual and family homelessness is broken out to detail differences from year to year between these key population groups. Dashboards identifying trends in homelessness for Maui can be viewed from the link presented in the Overview section.

Sheltered homelessness decreased 10 percent to 332 total people compared to the 369 that were counted one year prior. The total number of sheltered families was 49, identical to the count in 2024. Although the number of families was the same, the number of family individuals declined 11 percent to 170. There were 17 fewer individuals year-over-year, a reduction of 10 percent.
