PH Exit Rates by Island - Last 12 Months

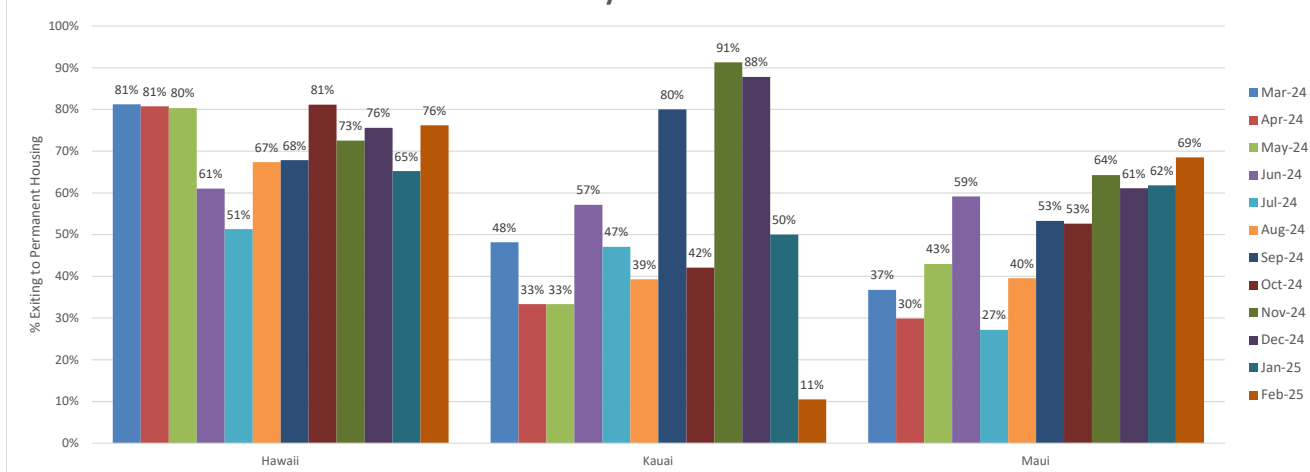

Figure 1: BTG's Percentage of PH Exits by Project Type

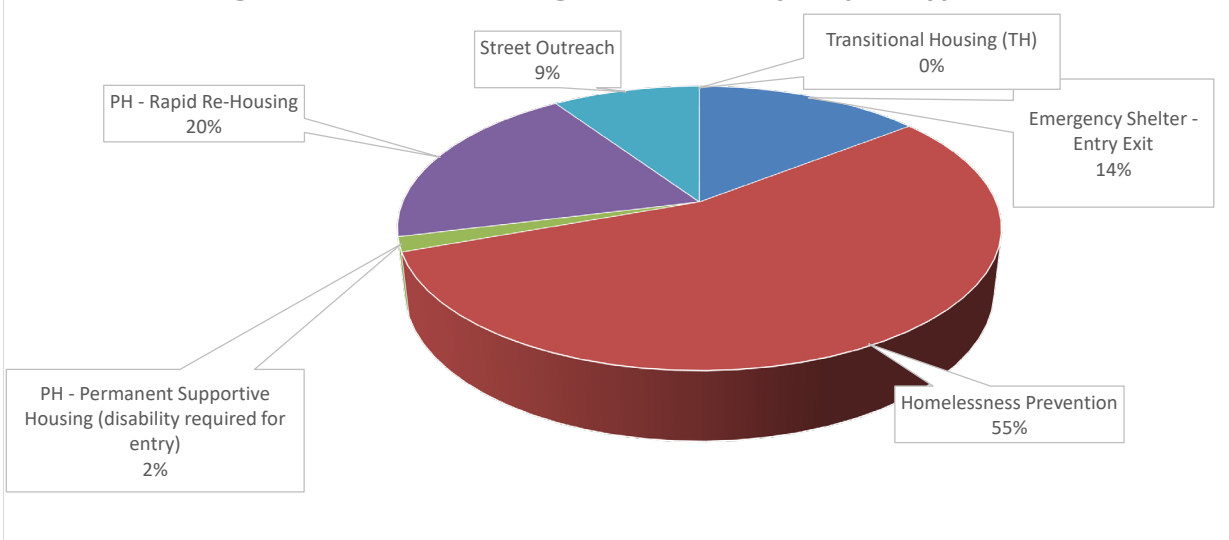
